- C. Superintendent's Report
- Met with Massachusetts Rural School Coalition
 - Wrote advocacy letter Rurality to key legislature members Peyser, Peisch, Baker, Riley, Chang-Diaz
 - Student enrolment decline, operating costs risen, per-pupil cost higher than the state average
 - Introduce rurality factor that is more systemic
 - Request for copy and to be shared with Mahar School Committee
 - There is no definitive rural definition other than neither urban nor suburban
 - Email to Susannah Whips
 - Rural school day February 7th
 - Shared services pilot (food services, etc. to have economies of scale). Checking with FRCOG and GCC to consolidate efforts and shared services
- Alternative Structured learning day programs (blizzard bags)
 - Letter of intent sent being discussed at the leadership team
 - Have the support of Swift River Education Association
 - Need to be mindful of students with lack of access to e-learning. Needs to be accessible to all students.
 - Pilot 2 days upon approval
 - E-learning is not a requirement but an option, one of many
 - Offer time to make up work
 - Rigorous work, meeting the standards of classwork in the school (not busy work)
 - A first snow day would be held as a snow day; second anticipated snow day will be Alternative Structured Learning Day
 - Elementary students guidance is not equivalent to that of middle and high school (need for more structure and supervision)
- How will activities be assessed?
 - Communicate with parents, students, staff after the pilot to see how effective this method is
 - The window of time to complete assignments up to five days
 - The work would be that of what would be expected of work in June when a snow day would otherwise be made up
 - Students will need to feel engaged with the assignment (reading, math,). Different activities and meeting both level of interest and the students' individual abilities
 - The activities would be completed in an anticipated 90 minutes- 2 hours
 - Examples given by Tina, 4th-grade teacher, measure snow in centimeters and make a chart of three different locations
 - Value of class time brought up. Time in school with teachers cannot be replaced
 - Engagement of students at the end of the year is vastly different.
 - Cost savings not having students in school in June? Not paying custodians overtime, still pay staff at the same level.

- Hourly staff would be allowed to continue their own learning (professional development) and compensated for time spent preparing 'blizzard bags' and completing work assigned by cooperative teachers or school principal. Office staff allowed to make up time in the summer
- Request for approval of pilot of two days from the committee to gain local approval of waiver application
 - Beth moves for a vote on Alternative Structure Learning Days pilot, Karyn 2nd. Passes with eight yes, one no
