 - Annual update on CNC
 - Funded by a grant by Massachusetts Early Education and Care
 - A small percentage of staff salary from the school budgets
 - CNC, public schools, libraries, and a few private programs are the only ones that support the learning of the youngest community members
 - Returning to more programming, especially outside programs
 - Programs continued through the pandemic as much as possible
 - Parent programs continue as well
 - Challenges level funding for the past 8 years: \$83,789
 - Limited supplies and personnel can work on this budget
 - Requests for needs have risen during the pandemic
 - The administrative and staff of U28 are very supportive of the CNC programs
 - Educating the legislature will be important for any increase in funds
 - Johanna and Barbra praise Gillian for her dedication and effort to the work the CNC does
