# E. Superintendant's report:

- SIMS reporting underway
- CPI training on de-escalating crises started with Nicole Suta trainer via grant funding
- Beginning lock-down drills with teachers mindful and supportive of students need for feelings of safety and calm
- Work underway on U28 budget for FY 24
- Working on roadmap for Student Support Services, including sending out surveys to students, families, staff, community to gather data for next steps
- MCAS performance at SRS above statewide results (YAY! Thank you teachers, staff)
- Schools anticipate a 14% increase in Chapter 766 school tuitions due to these schools'
  need to attract teachers/staff by increasing salaries/wages. Need for SRS students, families, staff, teachers, SC rattle legislator cages for increased Chapter 70 funding to cover
  such exigencies
- Learning Walks focusing on student engagement to re-start
- Application submitted for a Community Efficiencies Grant in conjunction with Shutesbury Elementary School with a \$32K price tag. If funded, grant will ferret out ways of blending needs at schools to increase overall efficiency and thus decrease budget expenses

#### Foundation Enrollment:

Superintendent Culkeen explained that the SIMS reporting underway is a mechanism the State uses to determine a school's Chapter 70 funding. The report determines the number of Resident Students in our school, which in turn determines funding. The definition of Resident Student is in turn predicted by factors such as actual student residence, incoming/outgoing SRS students, Special Needs student numbers, and other factors such as students who are non-English speakers, families that are low-income, etc. The final number of students determines the SRS foundation enrollment, which can then be used to determine our Chapter 70 funding. Detailed information is available on the MA Dept of Elementary and Secondary Education website.

Elizabeth Devlin: Any other funding opportunities? Sup. Culkeen: Hopefully an increased Circuit Breaker fund, push back on 14% private school tuition increase, grants.

#### F. Director of Finance and Operations Report:

Rough draft of FY 24 underway, EOFY 2022 sent to State. Vote to allow Chair to sign the EOFY

Certification Statement tabled until Jan 4, 2023 SRS SC meeting. EOFY report to be distributed to SRS SC before the Jan 4 vote.

# G. Principals Report:

- 132 students presently, with another 6 applying for entrance (2 from Wendell, 4 from New Salem, with 1 grade 6, 2 in grade 5, 1 in grade 3, and 2 in pre-K
- Have completed the Benchmarks and are beginning the Benchmark assessments
- Pandemic conclusions indicate there are some students who require more reading instruction. Some teachers trained in Wilson reading program to address need.
- Nexus Company installed effective remote heating controller and also replaced corroded pipes.
- Athletic fundraiser added \$900.00 toward \$20K needed to fund Nature's Classroom activity
- A new communication board installed in play area to enable children with communication needs to be able to communicate
- 8:45 Friday Community Sing has begun. COME JOIN and end your week with a song and a smile
- Over 2K miles logged in so far in 100 Mile Club GO SRS!
- Social/Emotional work underway
- 6<sup>th</sup> grade dissection of cow femur and chicken feet culminates series on Human Anatomy
- Towns approved installation of water treatment system into ground floor closet area. System awaits State approval prior to installation.
